We hereby instruct and authorise, until revoked in writing, the company

to clear our outgoing export shipments through customs on our behalf and for our account in accordance with Article 18 of Regulation (EU) No 952/2013 (Union Customs Code), on the basis of the CloseMRN Terms of Service (*), to complete the customs declaration, to sign it in a legally binding manner and to carry out all necessary actions in connection with the customs clearance.

The signatory confirms:

1. We are the exporter / seller of the goods to be declared.
2. The goods are, unless otherwise stated, products originating in the EU.
3. We will provide the customs tariff number and the description of the goods separately and in good time. If a customs tariff number is not available at the time of the export declaration, the agent is entitled to determine it independently on the basis of the information available. We undertake to provide our existing or subsequently issued binding tariff information (BTI) to the agent without further request and to inform the agent in due time if a BTI becomes invalid.
4. The goods are not dual-use goods and do not require an export authorisation; otherwise we will provide all necessary authorisations in the original in good time.
5. Where we hold authorisations relevant to the customs clearance, we will transmit them in good time before clearance.
6. Obligations under foreign trade law remain our responsibility. Existing embargoes and restrictions, as well as other limitations, in particular under customs legislation and international or policy measures related to international trade, have been complied with.
7. We assume responsibility for the completeness, accuracy and authenticity of all documents and information necessary for the execution of our instructions. Our statutory obligations as exporter remain unaffected.
8. The agent is entitled to grant sub-authorisations under this power of attorney.
9. We agree to the use and storage of our data for the purpose of the agreed contractual activities (details: Privacy Policy, closemrn.com/privacy).
